In a single analysis. SCC T provides the ability to identify most hazardous substances that are restricted or banned in consumer products by the individual retailer, by regulations of multiple countries, and by NGO focus groups. By identifying most hazardous substances before they are even used in productions, SCCT enables up to 90% to reduction in unwanted chemicals entering the supply chain and saves up to 70% of chemical testing costs.



Artificial Intelligence (AI)


